Textual Information(1)

On June 17 2025 the company has entered into the two corporate actions pursuant to the Resolution Plan approved by the Honable NCLT. The details are as follows 1. Reduction of Capital by way of reduction in face value and consolidation of no. of equity shares of the company. Reduction of the capital of existing shareholders through reduction in face value of equity shares. The face value of existing Equity Shares shall be reduced from Rs.10 per share to Re.0.10 per share with number of shares issued remaining at same level after the effective date. This would result in issued and paid up capital with 10100000 Equity shares of Re. 0.10 each with voting rights and aggregate paid up capital of Rs.1010000. After reduction of face value of the existing shares to Re.0.10 per share the face value of shares will be consolidated to Rs.10 per share which would result in reduction of the quantity of shares held by existing shareholders by 1 upon 100th of the existing quantity i.e. the shares of existing shareholders holding 10100000 Equity Shares will reduce to 101000 Equity Shares. Hence the paid-up share capital of the company will be 101000 Equity Shares of Rs.10 each aggregating to paid up capital of Rs. 1010000. 2. Issue and Allotment of Equity Shares to the Resolution Applicant. Issue and allot 1915000 equity shares at the face value i.e. INR 10 each at an issue price of INR 10 each by way of a preferential issue in accordance with the terms of the Resolution Plan as set out therein to the promoter i.e. Newage Intermediaries LLP maintain the minimum public shareholding below 95 of total shareholding of the company. Further, our new promoter "Newage Intermediaries LLP" hold the 204 shares acquired at the time of exit offer given by the company in July 2023, under escrow account under public category. These shares are not classified under promoter category till now, once all the corporate actions are done these 204 shares will be transferred to the promoter demat account and will be classified under promoter category.
